UNIVERSAL CREDIT

- Anyone who has little or no income, whether unemployed, employed or self-employed, may qualify for Universal Credit. It's designed to provide money for day-to-day living and rent payments.

- There's a 5 week wait to get Universal Credit. An advance can be requested if you're struggling.

ALREADY GETTING UNIVERSAL CREDIT?

- The Government announced an increase in Universal Credit of £1,000 per year. You'll get this on or after 6th April, but some won't get it until their June payment. If you're affected by the benefits cap you won't get the increase.
- If you're affected by the benefit cap, you could be a family who is exempted. This usually is on the grounds of disability. Contact us to find out more
- If you've had a deduction on your benefit for an overpayment, tax credits debt, or a loan, DWP should have suspended it for Covid-19.

RENT ARREARS—CONTACT US FOR HELP

You might be able to get a Discretionary Housing Payment if you're getting Housing Benefit, or Universal Credit with an award for rent costs. Our specialist housing team will help you.

COUNCIL TAX: You might get a discount on your payments - if you're single or disabled.

COUNCIL TAX SUPPORT: apply online—its a benefit that reduces your bill. For help with Council Tax Arrears Phone (02476 831111) or email counciltax@coventry.gov.uk

NEW BABY?

The register office is closed for Covid-19, but Child Benefit can still be claimed. You'll find the form on line. Add a note to explain that you can't register the birth. If you already get Child Benefit for another child you can ring 0300 200 3100 and register the claim

TEMPORARY RELEASE FROM PRISON

Due to Covid-19 some people have been temporarily released from prison. They can claim benefits. If the claimant has rejoined their partner then they can be added to the partner's claim.

The Home Office can change your conditions and allow you to receive benefits. If you need help with this get in touch with us.
